Plan committee Report-working on zoning and ordinance updates

Park Committee Report: - Dan has finished removing the logs that his machinery can handle. There are a few logs still in the park area. Heidi's Brench is level. Shelving has been installed at the park shed. More signage is needed for boat trailer parking. Nancy will provide a copy of boat launch/ trailer parking fee ordinance from the Town of Pepin. The trailer will be parked on site 12, at a cost of one months of camping fees. Mary Lane would like to plant some trees in the park to help replace the Ash trees.
