TUESDAY, JUNE 14, 2022 MEETING MINUTES

Village President Harley Cochran called the Regular meeting to order at 6:00 p.m. Harley discussed his decision and formal announcement on June 6, 2022 for the Emergency Appointment of Cindy Fayerweather as Deputy Clerk/Treasurer to fulfill the Clerk/Treasurer's duties during Heidi Krause's medical absence.

Roll Call: Harley Cochran, Dennis Reichert, Jerry Larson, John Krumm, Cindy Fayerweather were present.

A motion was made by Dennis, 2nd by Jerry to formally approve the appointment of Cindy Fayerweather as Deputy Clerk/Treasurer to assist Clerk/Treasurer Heidi Krause, all in favor; motion carried.

Clerk's Report: No report to date.

Treasurer's Report: The March, April and May financial reports were sent out. Motion by Jerry, 2nd by John to approve the Treasurer's reports; carried.

Park Committee Report: Jerry Larson, Park Chair reported the Park had income of \$5290 in May and \$3220 so far in June. The electrician is waiting for the park to dry out after the flood waters to complete the installation. Jerry is working on the park report. There have been 2 work bees, a lot was accomplished! Thanks to all who helped! The Park Committee would like to purchase a small storage shed for the park to house equipment and restroom supplies. Dennis estimated \$3,000 to \$5,000 in cost. This request wil be placed on the special meeting agenda. There has been a problem with garbage pickup this year. Paul's Industrial Garage (PIG) will be contacted.

Zoning Administrator Report: Roy Forstromm is out of town, table this discussion to a Special Board meeting the end of June to begin working on the Zoning concerns.

Planning Commission Report: No report.

Premier Resort Area Tax (PRAT) Committee Report: No report.

New Business:

- 1. Appointment of Cindy Fayerweather as Deputy C/T: Taken care of at the opening of this meeting.
- 2. A Special Village Board meeting was scheduled for the discussion/action regarding the 2022-2023 Liquor license applications and other items postponed by the Board.
- 3. The 2022 Board of Review will be held from 2:00-4:00 on Wednesday, July 13th at the Village Hall. Harley Cochran, Cindy Fayerweather and Dennis Reichert will attend with Jerry Larson and John Krumm as alternates.
- 4. ADA Park Project: New picnic table have arrived at the County shop building. 25 ADA tables will need to be assembled. Jerry and Harley will arrange to bring the tables to the village. The parking pad is still in the works.

- 5. Citizen Concerns: Frank Philips discussed the Timber rattlesnake issues due to the brush and debris piles on the Zerby property. The DNR recently removed and relocated 3 four foot long Timber Rattlesnakes from his neighbor's yard and were relocated. The concerns of the neighbors are the brush and debris piles on the Zerby property are creating additional habitat for rodents and drawing the snakes down off the bluff and into close contact with humans. The DNR estimates a den of 30-70 Timber Rattlesnakes are on the bluff but would need permission from the property owners for the DNR to investigate. Harley will contact the Village Attorney again as he hasn't heard back from him. John Krumm reported that he's been working on the Village Hall is going pretty well. Discussion was held on concerns regarding the request for a storage shed in the park; cost and vandalism concerns were voiced. Funding may be available for improvements in the village, more information will be coming.
