Clerk's Report: May Minutes reviewed and Jerry made a motion to approve the minutes seconded by Matt all were in favor.

Plan committee Report-Great meeting in May with Fred Weber and Josh Miller explaining their rolls has building inspector and Zoning. The plan Committee would like to create a small committee to come up with building or zoning application and fee schedule.
